Spring Fundraiser - is to raise monies for general fund and groups, as well as give back to community  
Scheduled Date - begin night of 04/22/2016 @ Roadhouse – Band with cover charge, groups can sign up for half & half  
end 04/23/2016 – downtown events – starting at 10am, vendors, food trucks, cornhole tournament, band at Virlies Grill with cover charge, vehicle give away (location of vehicle giveaway not determined)  
Vehicle Give away – 150 tickets @ \$200 each – no split  
Vehicle will be purchased by general fund  
Groups will not be charged vendor fee  
Groups should look to set up tents to see items, face painting, manage inflatables, manage cornhole tournament, contact local vendors for support  
Groups that want to cook must contact Lori Jasper regarding permits  
Adults must be present with all groups  
Stressed the need for more groups to participate  
More committee members needed  
Name Contest – groups can enter with name of Spring Fundraiser to win \$100 – forms handed out – deadline 11/13/2015  
No Auction will be held  
10x10 space for tents/vendors - \$50 each – will need two (2) spaces if you have trailer
